### President's Report

Another great year! We performed a record total of eight times for a variety of audiences: local aged care facilities, Down Syndrome Victoria's annual fun day, and St. Vincent's Hospital (for Care Week and Christmas carols). We were especially honoured to perform at head office of the Department of Health and Human Services for International Day of People with Disability. We also participated in two City of Darebin events – the Music Feast and Christmas carols.

Sarah Mandie's musical leadership is phenomenal. The introduction of new material and the use of percussion instruments (and kazoos!) has really lifted our performance.

Our volunteer team has been very stable, and we have been fortunate to gain new volunteers as well. I am amazed and grateful to have such a wonderful team of people supporting the choir. Particular thanks go to Jan Briggs, who accompanies the choir each week at rehearsals and when we perform.

A major achievement was the making of our short (about seven minute) video 'Why We Sing'. We thank our talented videographer Sam Osborn for enabling us to realise our vision. We hope to produce a few shorter videos during 2019.

Each term we produced an electronic newsletter, and each one featured a brief

interview with one of our singers. We continue to refine our communications to most effectively keep our singers, their families and carers and our general supporters informed about the choir. I want to thank Sally Green for all the work she does to do this and to keep the choir going.

Every year presents challenges. In 2018 we were able, through the efforts of many people, to meet challenges in funding and performing. Our total membership remains steady at around 30 singers. Including carers (who also participate) and volunteers, we have up to 60 people present for many rehearsals.

We have continued to involve singers in tasks and decisions related to running the choir. The choir has become more than just an activity for many: it is a friendship and support group in which all members are valued and appreciated. This is deeply gratifying.

Finally, I want to acknowledge the individuals who form our Committee – Katherine Wositzky (Vice President), Judy Rassaby (Secretary), Nettie Harper (Treasurer), Jan Clare, Tom Russell, Catherine Merry, David Joy and Scott McFie. Everyone makes a unique and valued contribution to running the choir.

## Treasurer's Finance Report January to December 2018

The financial report is for the 12 months from January to December 2018. This is the first 12-month report since the change in the Choir's financial year from 31 March year-end to 31 December year-end.

During the 2018 operating year there were cash receipts of \$29,086.92 and payments of \$23,990.28. Operating costs and fees paid to the Musical Director and the Administration Officer remained relatively stable.

The choir received substantial donations in 2018 that significantly contributed to the increase in the overall cash position.

Financial sustainability remains a challenge. Again in 2018 the high level of donations and substantial grants meant the cash position at the end of the 12-month period was increased to \$17,220.73. Membership fees contribute less than 10% towards the annual operating costs and the choir must depend on grants, fundraising and donations to make up the difference. The committee recognises that both the level of fees and the low collection rate are issues. In 2018 less than two thirds of the 30 registered choir members paid fees.
